- MaryFaith explains expenses for Liberty Mechanical is for the HVAC. The city has paid their share
 except for \$50,000. Willdan Energy are the engineers/consultants who handled the specs, bidding,
 supervising, and address any concerns we have. We received the switch gears which weigh about 1,000
 lbs. each and are in the garage awaiting installation.
- George Cattabiani is an elevator consultant. He did the technical specs and will be back in 2 months for final inspections.
- Exxon expense is for the gas for the van, for the month.
- Fitzgerald is the legislative manual, they wanted to do it this year online but Aimee likes it printed. It is a record of who is in legislature at a certain time and their biography.

- We received a check from Russell \$1000/ \$2500promised. Picture of note and check included.
- Pergola for Louise Fliger installed- pictures included.
- BrainFuse was lowered with a monthly cap.
- Library staff need a manual and training on the Building Management System.
- There are also issues with the Fan coil units and the air handler that cools the 4th floor.
- We will have to close 7/10,11 and 12 for the switch gears which are currently in the garage. They weigh approximately 1,000 lbs. and power to the building will need to be cut while they are installed.
- ADT equipment- foul odors in the bathrooms from the sewer lines which are tripping the smoke detectors. We have to flush fresh water down the drains daily.
- We received 4 free book trucks from the Middlesex Public Library.
- Elmora was the polling site for late voting for the primary election. 125 people attended.
- In May 118 people attended our computer classes. We offered 7 1on1 sessions.
- SAM software registered 4000 individual computer sessions.
- Newark Airport a little girl created a small library at the airport. They asked if EPL can go over there and stock it with books. They wanted us to do this on a continuous basis. We put out free books here to the public/to our community. Doing this at EWR seems a little off-target.
- We have a decent DVD circulation but looking into streaming which is a popular way to go.
- Robert will organize a volunteer launch this summer for volunteers; all trustees are volunteers and will get an invitation.
- Over 100 attended GED Graduation NJ Lit. Largest graduation class they ever had and they were pleased.
- Teens are debating having an overnight sleepover in the Library.
- Someone coming in with a hard HEART grant for art classes -15 students 1x/mo and they supply all material. Acrylics. July-August.

- Elmora book sale 8/5-8/12. Usha attended the Youth in Government Day for MaryFaith.
- Four of the staff attended Circulation Summit sponsored by LMxAC in Sayreville.
