• MaryFaith explains expenses for Liberty Mechanical and Jersey Elevator and Willdan

Energy Service. Ms. Pearl Serratelli said hopefully next year we will not have HVAC

and elevator expenses. Lorraine Tidd said she had a bit trouble with the elevator.

MaryFaith said the button gets stuck and she will let the maintenance vendor know.

• Edwin Lopez re-imbursed for \$1600- re-imbursement for Latta where we display daily

events on the TV screens which informs patrons what is happening.

• John's Caffé was for the Staff Development Day- everyone enjoyed it. We had Employee

Assistance Program. Then we had the Improv group, with bonding and team building

exercises. We had the Union come in for Q&A. Afterwards, Active Shooter Training by

EPD officer who took us through the building.

DIRECTOR'S REPORT:

Consult your packet for the complete report.

- MaryFaith discusses D'Andre who punches the air and uses foul language. If you talk to him and treat him with respect he is compliant but then there was a sexual harassment incident to be discussed in closed session, and he was banned for 2 months from the library. Another woman Debra, who worked for the prosecutor's office was also banned, as she does not bathe and may carry microbes; we are within our rights to ban her. A woman named Darlene interacted in a negative way and is also banned. If they show up, the length of the ban is extended.
- Thank you for attending dedication for Dan and Anne Russell. We have language for Nesbitt.
- HVAC project is reaching conclusion; a/c is still not on. All work has been completed by Liberty. The chiller must be turned on by the manufacturer of the chiller, Daikin, otherwise warranties are void. There is a leaking valve in the ceiling of the boiler room affecting 2 pipes below it. There was a flood in the boiler room while electricians were working. The switch gear is expected late July and there will be a 3-day closing to install. The switch gear is a large piece of equipment. The A/C can go on as soon as the vendor comes in. If interior temps reach the mid-80's we have to close for safety reasons.
- Staff elevator modernization: we needed smoke detectors in the new elevator. It is a big project as a smoke detector is needed on each floor 5 feet from the elevator. Today the ADT tech explained the process and how the process can delay staff elevator for 2-3 months. We hired an elevator Consultant but he did not explain this clearly nor how long it takes. MaryFaith is frustrated with that. Our current smoke detectors are not addressable but the upgraded ones will be. Cost is approximately \$25k. Everything has to be hard-wired in. It would make sense to upgrade all smoke detectors at this time, not just the ones that must be done for the elevator. Edwin hooked up the phone line in the elevator. There are minor issues upstairs in the machine room. The new equipment was installed so that you have to go *over* the equipment to get inside the room and there is a hazard with a large window. We have had to re-inforce the window with a metal grid for safety reasons.
- Broad Street doors: The staff forgot how to do properly lock it. They thought an Allen wrench was needed. A key is needed and the staff were retrained with hands-on approach. A security guard arranged for a temporary lock with a chain. Ms. Pearl Serratelli said we get new people all the time and the people here a long time forget. MaryFaith said during Covid, we did not have some things going on, so we needed a refresh.
- Usha is concerned about leaks at Elmora- MaryFaith asked the architect twice about the bid packets and has been told "soon."
- Lots of people are attending the Computer classes and Citizenship class. IRC was here and is expected to host 25 people weekly.
- Art work-shops are popular with all departments and summer reading is starting soon.
- Mr. Ted Freedman asks about BrainFuse. We overspent on computer database. We will adjust audio/visual with fewer DVDs & increase Streaming services. We will look to see what streaming services we can afford. MaryFaith received a call from a rep at BrainFuse who said usage was really good and if we paid for actual usage we would pay 60k instead of 11k. There are many services Freegal, a music source, and HOOPLA,

which bases cost not on population size but usage. Usage can always be capped. Hoopla is for entertainment and BrainFuse is educational with live tutoring and practice tests for GED and Citizenship. We have the service from 2pm-11pm. Students struggling can go on-line to BrainFuse and there is a live tutor who will guide them. We cannot afford 60k. MaryFaith has asked if the school district can partner with us and share in the expense for BrainFuse. MaryFaith can go back to City Hall as well. People are using and accessing BrainFuse and we would run up to the cap quickly. Mr. Michael Ojeda wonders if it is possible to get data on the number of students using the service. MaryFaith notes that only the total number of sessions is available. MaryFaith suggests we may have to cap usage at \$15,000 per year, spread across 12 months. MaryFaith notes that the contract expires at the end of June.

• Mr. Martin Weingast asks what kind of accounts the library money is kept in; he notes rates for CDs are 3.65 % at Valley Bank and 4.65% for regular checking account. We could earn about 17k in interest. MaryFaith said we have the bulk of the money, \$800k, in a Money Market account. Ms. Pearl said we can do CDs for 3-6months at a time. Interest rates are low at this point. MaryFaith said as of April \$125 in interest has been earned. Lisa Torres said put part of the money in a higher interest bearing account. MaryFaith said we can make a resolution next month.
