Julia concerned federal government cuts may effect library.

PRESENTATION AND APPROVAL OF BILLS (MARCH 2025) (Action Item):

We received a bill from the City for \$118K for retiree health benefits. While we budget \$5,000 monthly for retiree health benefits paid to the State, this is an additional amount billed by the City for other retired employees. These benefits are paid through the City rather than directly from the Library and appear to be the result of a prior arrangement

The Library purchased 20 computers for staff/public with Win 11.

Literacy NJ and the Library partnered for \$51k Grant. The library receives the grant and pay NJ Lit their portion. They use library facility for HSE, ESL, computer, and other classes. They have their own volunteers and handle everything else.

11. REPORTS OF AD HOC COMMITTEES:

Friends of the Library needs to be established. We need an attorney to set up 501-C3. They can apply for grants the library cannot apply to. They can help pay for children's programs, museum passes, author talk etc. FOL can charge for items/tickets and give % sales of tickets to the library. We can get funds from businesses in the area if we also open up Foundation.

Budget & Finance Committee: Martin Weingast reviews his earlier meeting where he, Earnestine Smith and Eleni Glykis discussed a basic understanding of the budget. Mr Weingast continues working with Eleni on the budget and finance protocols.

12. <u>REPORT OF THE DIRECTOR:</u> Consult your packet for the complete report.

A change order of \$8,000 was approved on 3/10/25 for the demolition of the chimney. The cost is covered by the contingency allowance in the budget. Bi-weekly meetings with the architect are ongoing. After the roof work is completed, enveloping work will begin at the Main Library.

In 2024 the Elizabeth Public library had over 350,000 visitors, circulated 138,058 materials and provided 1,750 programs with a total attendance of 24,534. We also facilitated over 18,000 interlibrary loans and maintained a strong digital presence, with over 60,000 public computer sessions and 19,000 wireless sessions.

At the LaCorte Branch, the sidewalk has been redone. Over at the Eport Branch, some issues have arisen with the alarm system and are currently being addressed.

Martha from the Elmora Branch was nominated as a Library Unsung Hero. Due to a conflict of interest—since the NJLA President is an Elizabeth employee—the nomination couldn't move forward. However, we would still like to acknowledge and commend Martha for her excellence and dedication.
